INFORMATION ON ELECTRICAL CONTRACTOR LICENSING REQUIREMENTS

Complete the “Application for Electrical Contractor’s License” and the “Master Acknowledgment of Responsibility Form” in full. Date, sign, notarize, and return both forms to this office with the required fee for review and approval to:

ELECTRICAL CONTRACTOR is defined as any person, firm, co-partnership, corporation, association, or combination thereof who contracts or offers to contract for another the planning, laying out, supervising, and installation of additions, alterations, and repairs, or the installation of wiring, apparatus and equipment for electric light, heat, and power. All work done under the conditions above shall be under the direction and supervision of a master electrician who is actively and solely employed by the contractor.

A person, firm, etc., **shall not** perform any electrical contracting work in the State of Wyoming until such time as an application has been made to, and a Wyoming electrical contractor’s license has been received from, the Chief Electrical Inspector.

Any contractor who fails to have all electrical work properly supervised by a master electrician of record may have his/her contractor’s license suspended or revoked at the discretion of the Electrical Board.

THE FOLLOWING FEES SHALL BE PAID BY THE ELECTRICAL CONTRACTOR:

Initial fee for electrical contractor’s license & renewal \$400.00
(Renewal fee is on a yearly basis on or before July 1, and is \$400.00)

The application must be accompanied by the proper fee in the form of a company check, money order, certified or cashier’s check made payable to the State of Wyoming. Personal checks will be accepted providing that the individual/company has not written insufficient fund checks to the State of Wyoming in the past.

Every employee of an electrical contractor performing electrical work in the State of Wyoming will be required to be licensed as a master or journeyman electrician, hold a valid temporary work permit as a journeyman, or be registered as an apprentice electrician.

APPRENTICE ELECTRICIANS

An electrical contractor may employ apprentice electricians to assist a licensed journeyman or master electrician. Apprentice electricians working for an electrical contractor in the State of Wyoming must be registered with the Department of Fire Prevention and Electrical Safety **within 10 days** of hire, or beginning work in Wyoming. The electrical contractor shall register the apprentice electrician by sending a completed apprentice registration application, which will be provided upon request or at renewal times, to this office. The application must also include notarized letters of previous experience or a Wyoming employment verification form if it applies as well as the appropriate fees. Upon approval of apprentice registration the apprentice will receive an apprentice registration card. This apprentice registration card is to be carried by the apprentice electrician at all times and shown at the request of the proper authorities.

Apprentice Electricians shall be enrolled in a bona fide program of training approved by the Bureau of Apprenticeship and Training, The United States Department of Labor, or present evidence directly to the board that he/she is enrolled in an apprentice-training program which provides training equivalent to a program approved by the Bureau of Apprenticeship and training. Required training is 144 hours per year.

Registration of apprentices shall be updated yearly on or before September 1 with documentation of the number of hours of work experience and classroom experience obtained since the previous September 1. A \$20.00 apprentice registration fee will be charged for the initial registration and yearly renewals.

An electrical contractor shall not employ more than **two** apprentices for each licensed journeyman or master electrician on the job site (effective July 1, 1995).

Upon termination of employment of any licensed electrician, the electrical contractor shall notify this office of the termination **within 10 days**.

LICENSE REFUSAL, SUSPENSION, REVOCATION, AND APPEAL

The Electrical Board may, at its discretion and for good cause shown, refuse to issue a license to any person, firm, or corporation or may suspend or revoke an existing license for, but not limited to, the following reasons.

- (a) Continued and/or flagrant violations of the Wyoming Statutes, Rules and Regulations as promulgated by the Electrical Board, or the National Electrical Code.
- (b) Aiding or abetting, counseling, encouraging, hiring, commanding, or otherwise procuring another to violate the provisions of the Wyoming Statutes, Rules and Regulations as promulgated by the electrical board, or the National Electrical Code.

Appeals shall be taken as provided in current Wyoming Statutes and the Current Rules and Regulations.

NATIONAL ELECTRICAL CODE

The State of Wyoming adopts the National Electrical Code without modification. The examination for licensing is based on the current edition of the National Electrical Code.
